HUMAN SERVICES IN THE FY 2018 BUDGET

On May 2, 2017, the Fairfax County Board of Supervisors adopted the FY 2018 Budget, which begins on July 1, 2017. Supervisors Kathy Smith and Daniel Storck voted "no." The Board approved County Executive Ed Long's recommended increases and reductions in human services funding, but, in response to community advocacy, made the following changes:

• Restored \$150,000 to the Insight Memory Care Center (IMCC) contract for one year to provide additional time for IMCC to modify and adapt its business model to improve fund raising capabilities.

• Restored \$373,303 for the CSB's Community Readiness and Support Program, thereby preventing the elimination of the program.

• Added \$1,995,000 (and 18 positions) for partial funding of the planned second year development of the Diversion First Program, in order to meet the next phase of requirements for this initiative. Seven of the positions (\$725,000) will be allocated to the CSB.

BUDGET GUIDANCE FOR FY 2018 AND FY 2019

As part of its budget deliberations, the Board of Supervisors approved a number of Budget Guidance items for the future. Several may be of interest to human services advocates and providers:

• Diversion First: The Board commented that, given current revenue projections and competing priorities, it may be difficult to fund this program as originally envisioned. Therefore, staff is directed to develop a five-year, fiscally-constrained implementation plan that "continues significant forward progress, while operating within realistic fiscal goals."

• Opioid Use Epidemic: Staff is directed to continue to provide ongoing updates on the work being done and any changes in the impact of the epidemic on our community. Staff is also directed, as recommended by the Human Services Council, to continue to work with all partners on strategies to combat the epidemic and to identify funding needs the Board should consider during FY 2108. The Board will consider a reserve for this purpose at the FY 2017 Carryover Review.

• Human Services System Resources: The Board directs staff and the Humans Services Council to use the 2016 Human Services Needs Assessment as a "roadmap" to identify priority funding needs over the next five years. The plan should recognize that the County will be fiscally constrained during this period.

• Employment and Day Services for Individuals with Developmental Disabilities: The Board has postponed a decision on the CSB's recommended model for delivery of these services and directs staff to continue to evaluate this model and return to the Board with an update by September 2017. The Board will then provide direction on how to proceed with service delivery in FY 2019.
